Privacy Policy

Bull Horn Games (the “Forum”) is dedicated to upholding strong privacy protections for its users. Our Privacy Policy aims to clarify how we collect, use, and safeguard the information you provide to us, empowering you to make informed decisions when engaging with our Service.

For the purposes of this Policy:

“Site” refers to the Company’s website, accessible [here](#).

“Service” refers to the Company’s services accessed via the Site, allowing users to connect with staff and report issues.

The terms “we,” “us,” and “our” pertain to the Company.

“You” denotes you, as a user of our Site or Service.

I. INFORMATION WE COLLECT

We gather both “Non-Personal Information” and “Personal Information.” Non-Personal Information comprises data that cannot personally identify you, such as anonymous usage data, general demographic information, referring/exit pages and URLs, platform types, preferences you submit, and preferences generated from your submitted data and clicks. Personal Information includes your email and location (COUNTRY) submitted through the registration process on the Site.

Information collected via Technology

To activate the Service, you need only provide your email address. Further Personal Information [is/is not] required to utilize the Service, which may include: list Personal Information collected.
